

President, two Chairs and two Co-Chairs re-elected at Council of European Energy Regulators (CEER)

Ljubjlana, 12 December 2023

Today, the General Assembly of the Council of European Energy Regulators (CEER)¹ re-appointed Dr Annegret Groebel (BNetzA, Germany) as the CEER President for a third term. Dr Groebel's mandate takes effect on 24 January 2024 and will run for the next 2.5 years. She is supported by five Vice Presidents, Jana Haasová (ERÚ, Czech Republic), Koen Locquet (CREG, Belgium), Alda Ozola (PUC, Latvia), Wolfgang Urbantschitsch (E-Control, Austria) and Pedro Verdelho (ERSE, Portugal). Their term runs until 11 May 2025, equally for 2.5 years.

During the same General Assembly meeting, CEER also re-elected Ms Christine Materazzi-Wagner (E-Control, Austria) as Chair of the Electricity Working Group (EWG) and Mr Veli-Pekka Saajo (Ev, Finland) as Chair of the Distribution Systems Working Group. Additionally, the General Assembly re-appointed Ms Esther Espeja (CNMC, Spain) and Dr Groebel to continue to Co-Chair the Market Integrity and Transparency Working Group.
