- Broad vision of Europe's energy landscape both within and beyond EU borders (31 NRAs)
- Promotion of European objectives for the achievement of an internal market
- Addressing a wide range of regulatory and market issues



CEER priorities in 2013

- 1. Customers
- 2. Development of competitive wholesale and retail energy markets
- 3. New legislative/policy developments
 - Sustainability
 - New Infrastructure
 - Market Integrity
- 4. International work





- In 2012, CEER launched initiative to build "2020 vision for Europe's energy customers"
- During 2013, plan to implement our action plan and address specific issues, including:
 - Data management
 - Involvement of consumer orgs. in regulatory process
 - Smart metering
 - Customer access to info on the costs of energy



Development of competitive wholesale and retail energy markets

- ACER addresses aspects of EU wholesale markets
- CEER complements ACER in certain areas, including monitoring market developments (LNG, gas transparency, TSO/DSO unbundling, customer rights) and addressing technical aspects of energy:
 - Quality of electricity supply
 - Blackout prevention
 - Flexibility tools for markets with RES
 - Incremental capacity auctions and open seasons for gas infrastructure



New legislative/policy developments

- Regulators are committed to powering the EU energy debate and to serving as valued partners to the European Institutions in shaping energy policy and legislative proposals, in particular on:
 - Sustainability
 - New Infrastructure
 - Market Integrity



International work

- CEER has longstanding relations with non-EU regulators:
 - Bilateral ties (e.g. Russia and US)
 - Regulatory associations (e.g. ECRB, MEDREG and ICER).
- Regulators will continue strengthening the cooperation of CEER with these and other institutions





- Consultation closes 30 July 2012
- CEER will review comments and update the WP, drawing from:
 - 21 June Customer Conference and feedback to Vision discussion paper (deadline 16 July)
 - WP consultation feedback
 - Internal considerations and developments, including the availability of expert resources
 - Publication of final CEER and ACER 2013 WPs in October 2012
