Regulatory Practices for the Promotion of Energy Efficiency

In June 2010, the International Confederation of Energy Regulators (ICER) published a report on Regulatory Practices for the Promotion of Energy Efficiency. The report presents information gathered from the world's energy markets on regulatory practices aimed at fostering energy efficiency, including a overview of the role of energy regulators in the promotion of end-use energy efficiency. The ICER report is a particularly useful reference point on energy efficiency practices from across the globe, allowing comparison of energy efficiency policies between EU countries (all 27 Members States are covered) and other regions (Africa, North and South America, Asia, Australia and Oceania). Energy regulators have committed to continue this global cooperative work on energy efficiency by reviewing best and promising practices on the promotion of energy efficiency through case studies.

ICER takes the opportunity of the European Union's 2011 Sustainable Energy Week to place a spotlight on energy efficiency which (at least in Europe) has been largely untapped as a way to deliver energy savings and help achieve a secure and clean energy future for all.

With this in mind, we would like to showcase several international perspectives on energy efficiency from the International Energy Agency to the European Commission to individual country experiences.
