

Regional cooperation

- Two different issues:
 - Composition of the regions
 - Purpose of the regions





Definition of the regions

- Via a definition of regions contained in Annex I, based on a number of criteria (Article 3)
- Why are regions defined in the legislative proposal?
 - The ordinary legislative procedure (OLP) is the most open and participative procedure
 - Ensures the application of the Regulation as of "day 1"
- Amendments are possible (delegated acts)
- Top-down vs bottom up? Or Mandatory vs voluntary?
 - Any proposal of regions, as part of the OLP, will require the agreement of the EU legislator
 - A cooperation à la carte is unlikely to deliver the same benefits, nor to be applied throughout Europe (examples in the past).



Purpose of the regions

- Why?
 - The most effective tool to improve prevention (better estimation of risk magnitude, early identification of synergies and inconsistencies)
 - To ensure a consistent and larger response in a severe crisis
- What is the added value?
 - Experience shows there is real added value:
 - Ensuring consistency of measures
 - Ensuring full awareness of the type of measures to be deployed by your neighbours and when
 - Clear opportunity to exploit synergies
 - reducing costs of SoS measures for consumers!



National Plans vs(?) Plans at regional level

- NO!. Each Member State <u>MUST</u> prepare its national measures ahead of engaging in the regional discussion (Article 7(2) of the Commission's proposal).
- Need for an <u>integrated document</u> containing national & regional measures to ensure full consistency and true consultation (avoid tick in a box!)
- There is no loss of sovereignity.



Powers of the Commission

Current system: opinion + "name & shame"

Proposal: opinions + decisions



Only if certain conditions are met



Solidarity

A one-size-fits-all approach is unlikely to work in this case

The necessary arrangements need to be agreed among Member States in question, including technical, administrative and financial issues.

- Member States have already in place procedures for similar situations (emergencies) at national level. The same procedures can be applied a political question?

Solidarity

- A number of principles (non-paper):

 - Market-based as much as possible
 - No perverse incentives
 - Compensation costs must be paid by beneficiaries
 - Proportionality in costs and burden (based on existing mechanisms as much as possible)
 - Certainty for actors involved must be provided (framework)
 - Transparency in advance about likley affected gas volumes



Transparency of contracts

- Proportionate and clear approach:
 - Targeted mechanism for specific cases based on "lessons learnt".
 - Contracts:
 - Limited number of contract subject to automatic notification
 - Addicional mechanism to prevent any "by-pass"
 - Clear obligations for suppliers affected
- No clash with other instruments
 - different scope and purposes
