

European Commission congratulates energy regulators on their customer vision

The Council of European Energy Regulators (CEERⁱ) hosted today, during Sustainable Energy Week, a novel interactive customer conference (in Brussels) where consumers could contribute to the definition of a future strategic vision that meets Europe's energy customers' needs.

CEER is building, with customer bodies, a 2020 vision for Europe's energy customers

The CEER "Building a 2020 Vision for Europe's energy customers" conference (21 June) was the first step in a process led by regulators to build together with consumer bodies, the EU Institutions, industry and others, a 2020 vision for energy customers.

Six weeks in advance of the event, CEER published a discussion paper '2020 vision for Europe's energy customers'. It outlined what CEER sees as the key principles that consumers expect from the energy market: reliability; affordability; simplicity; protection and empowerment. This paper formed the basis of the discussion at the interactive event and which will in turn lead to the detailed Vision.

Strong political support by the European Commission for the regulators' initiative

The European Commission provided the venue, interpretation in multiple languages and the highest level speakers. Opening the CEER conference, Energy Commissioner **Oettinger**, said: *"Let me thank CEER and Lord Mogg for bringing together so many stakeholders to discuss a key element to the success of the electricity market reform – the consumer."*

Highlighting the links with the Commission's new proposal for a "European Consumer Agendaⁱⁱ", Ms Rossella **Delfino**, from Commissioner Dalli's cabinet, "*congratulate[d]* the energy regulators on showing leadership and commitment in their engaging initiative to build a vision for Europe's energy customers".

BEUC welcomes energy regulators efforts to involve national consumer bodies

Six national consumer bodies each told their story of energy customer empowerment during the event. The interactive breakout sessions allowed all participants to discuss, in small groups, key questions based on the four core principles of the CEER discussion paper.

"Of the 200 delegates at our conference, the consumer voice was represented by 37 national consumer body representatives, who clearly welcomed the opportunity to share their views about the changes facing energy customers. We are now taking stock of their input in further developing our Vision Paper for London Forum in November 2012." Lord Mogg, CEER President.

President of BEUC (The European Consumer Organisation), **Paolo Martinello**, said "*The energy* regulators' initiative of developing a future vision for energy customers is the first example of a sectoral regulator involving a wider spectrum of stakeholders and could be a role model for other sectors."

CEER invites comments on its '2020 vision for Europe's energy customers' paper - deadline is 16 July 2012. A more developed CEER Vision and action plan will be presented at the 2012 London Forumⁱⁱⁱ.
