

## Regulators see competitive markets as key to safeguarding Europe's security of supply

- CEER launches two new reports: on Renewables and LNG
- Andrew Ebrill is CEER's new Secretary General

During today's showcase annual conference, the Council of European Energy Regulators (CEER¹) assembled regulators, European Commission officials and energy sector representatives for a high level discussion on safeguarding Europe's security of electricity and gas supply.

Highlighting that competitive markets underpin the Energy Union's security of supply objective as well as regulators' own work, Lord Mogg, CEER President explained:

"Energy regulators contribute to Europe's energy security. Inmarket design and its regulation, regulators help ensure an appropriate investment climate for infrastructure, and by reinforcing best regulatory practices within and beyond Europe."

## **CEER launches two reports: on Renewables and LNG**

Today, 2 new CEER reports were accounced. Firstly, the CEER's report on "key support elements for Renewables (RES) in Europe: moving towards market integration" is a key input in the future Euopean energy system where RES will play a key role in achieving the transition towards a low-carbon energy system:

Secondly, CEER will soon publish an LNG report. It shows how regulators' work contributes to the security of supply debate and in particular the expected adoption of the European Union strategy for LNG and gas storage.

Tim Gould (International Energy Agency) explained that the COP21 pledges hasten a shift in the focus away from external gas security (e.g. import dependency) towards internal (e.g. infrastructure, storage and flexibility).

## Andrew Ebrill is CEER's new Secretary General

The conference was also the opportunity to announce new beginnings with <a href="CEER's 2016">CEER's 2016</a> work programme and the appointment of Andrew Ebrill as CEER's new Secretary General. Welcoming Andrew, Lord Mogg said:

"Given Andrew's extensive energy and management experience, he is well placed to manage the CEER Secretariat and lead the many initiatives of our European association of energy regulators, delivering better regulation for energy markets to thrive."
