

DRAFT COURSE PROGRAMME



This course enables Commissioner-level and senior-level staff of National Regulatory Authorities (NRAs) to reflect on their NRA's role and effectiveness with the implementation of the "Emergency measures" to overcome the energy crisis and the role of regulators in the energy transition.

This intensive and exclusive one-day online programme provides a unique opportunity for participants (Commissioner-level and senior-level NRA staff) to learn and exchange views on the implementation of the Emergency measures as well as contributing to the targets of climate neutrality as set out in the Green Deal and the "Fit for 55" packages. Based on the CEER 2022 – 2025 Strategy "Empowering consumers for the energy transition", the changing needs for regulation to contribute to the energy transition by adapting their regulatory tools in times of change will be analysed and looked at. The programme offers a first-hand opportunity to learn from fellow senior regulators, policy-makers and energy actors who are directly involved in energy regulatory policy development and implementation.

SESSION 3 CEER 2022 – 2025 Strategy: Empowering Consumers for the Energy Transition Chair: Ms Annegret Groebel

The "CEER 2022 – 2025 Strategy Empowering Consumers for the Energy Transition replaces the CEER 3 D Strategy (2019 – 2021). As the title indicates it puts the consumer in the centre of the energy transition and is built on three pillars: Enabling energy system integration, Placing consumers at the centre of energy markets with consumer-centric dynamic regulation, and Ensuring open, well-functioning, and resilient markets nationally and in Europe. Based on this the Strategy aims to contribute to the energy transition towards carbon neutrality with adequate regulation focusing in particular on consumers. As can be seen, the element of dynamic regulation continues to be an important element of the CEER 2022 – 2025 Strategy as regulation has to be able to swiftly adapt to new challenges while remaining predictable by following fundamental well-proven regulatory principles. Another aspect is the experience and lessons learnt from the pandemic and how this might increase risk preparedness generally.

This later aspect was not the main focus when the CEER 2022 – 2025 Strategy was developed, but in the light of the current crisis might serve to provide approaches to quickly adapt to the challenges and react in a more prepared way. Starting from the CEER 2022 – 2025 this session will discuss the various aspects and tools regulators have at their hand to contribute both to the energy transition and support emergency measures to overcome the current energy crisis (linking it back to the first session).

14:45 – 15:15 Regulating an industry with continuing decreased sales and regulating existing infrastructures for different purposes. Regulating the multi-sector, multi-level energy architecture, regulating an energy system with a growing share of renewables, how to ensure the system becomes flexible.
