

Moldova joins the Council of European Energy Regulators (CEER)

Today CEER, the European association of energy regulators¹ admitted Moldova as an Observer, with effect from 1 January 2017.

Moldova's National Energy Regulatory Agency (ANRE)² is the latest national regulatory authority (NRA) from the Energy Community to join CEER.

Welcoming ANRE, CEER President, Lord Mogg said:

"2016 was a major milestone for Moldova with the new electricity and gas laws. We welcome Moldova to CEER and will help ANRE implement the 3'd Package requirements. Moldova's participation in CEER will be of mutual benefit. Together we will work together to better integrate energy markets throughout Europe and its neighbouring regions."

Mr Sergiu Ciobanu, Director of ANRE, said:

"Being a European regulator is not something we take for granted in Moldova. Joining CEER brings the benefit of a network of fellow regulators willing and able to share their experience implementing Europe's energy laws, best practices and on the job training for our staff."

CEER serves as a platform for energy regulators within and beyond the borders of the EU-28 Member States of the European Union³. CEER's broad vision of encompassing key transit countries and countries on the periphery of Europe in close energy dialogue and regulatory cooperation is aligned with the external dimension of the "Energy Union.

CEER brings together 34 national regulatory authorities (NRAs) from EU Member States, EFTA and EU accession countries, including from the Energy Community⁴.
