Abstract

On 29 May 2013, the European energy regulators launched a public consultation on the draft CEER 2014 Work Programme (Ref. C13-WPDC-23-05). This document outlines CEER's work plan for 2014, centred on four overall strategy focus areas.

Stakeholders are invited to provide their views via an <u>online questionnaire</u> by 21 June at the latest.

Energy suppliers, traders, electricity and gas customers, electricity and gas industry, consumer representative groups, network operators, Member States, academics and all other interested parties.

1. INTRODUCTION

Through CEER, regulators share experience and develop good regulatory practices in areas important to national energy regulatory authorities (NRAs). Important priority areas include customer rights, fostering competitive markets and maintaining and strengthening our dialogue with regulators around the world, through which CEER aims to identify and exchange good international practices, and to identify critical issues which may soon face the energy sector.

In 2014, CEER will extend the internal services it provides for member NRAs by the further development of good regulatory practices, particularly in relation to situations in developing economies and small and isolated markets. In addition, European energy regulators have identified that a longer term view on some developing issues, such as the impact of introducing smart technologies into the networks, would help with the organisation of an effective regulatory response. CEER will therefore also undertake analytical work examining key upcoming issues facing the energy sector, on which it will consult stakeholders.

In undertaking these activities, CEER pursues a broad variety of issues of interest to regulators. European energy regulators also work within the EU Agency for the Cooperation of Energy Regulators (ACER), focusing on its statutory tasks relating to the development, implementation and monitoring of the cross-border regulatory framework for the effective operation of the Internal Energy Market. In order for stakeholders to see easily the work of both CEER and ACER, both organisations are working to a roughly parallel timetable for the development of their draft 2014 work programmes.

We invite comments on the CEER draft work programme by 21 June 2013. This year we do not plan to hold a workshop on the CEER work programme. However, CEER is holding an Annual Conference on Energy Customers on 19 June 2013 and that will be an opportunity for consumers to provide views orally on CEER's draft 2014 Work Programme.

Stakeholders are invited to participate in the public consultation via a dedicated online questionnaire in the public consultation section of the CEER website. Please note that only answers submitted via the on-line questionnaire will be taken into consideration.

2. OUR PRIORITIES IN 2014

CEER will continue to concentrate on enhancing the capability of EU NRAs to fulfil effectively their individual European responsibilities for achieving a **competitive**, **sustainable and secure energy market in Europe**. CEER will continue to engage fully with policy makers to help in the development of a sound and sustainable single European energy market. CEER will enhance collaboration between member NRAs to share experiences, and to identify good regulatory practices.

CEER's priorities for 2014 will continue to emphasise the increasing role that customers will play in the development of energy markets.

We will also continue to develop our international relations with regulators across Europe and globally.

We will seek to identify a limited number of issues which are likely to impact on European energy markets and we will seek the views of stakeholders on the extent of their likely impact, and on what measures should be taken to address them. As illustrative examples, the issues addressed in this way could include topics such as the future role of DSOs, and demand side impact on the grids. We would welcome views on the specific issues CEER could examine in 2014 as a matter of priority.

2.1. CUSTOMERS

CEER's initiative of building a 2020 vision for Europe's energy customers is aimed at putting consumers at the heart of Europe's internal energy market (IEM). This will remain a key issue for regulators in 2014. We continue to champion consumer rights and emphasise in our communications that the benefits to the consumer are the ultimate goal of sound energy regulation. Through the deliverables from our Work Programme and ongoing efforts, we will continue to develop and promote communication tools such as our dedicated customer web pages. We are also committed to bringing energy regulation issues closer to consumers with the continuation of the inclusion in all CEER reports of a customer section and an accompanying Citizens' Q&A memo to explain briefly and simply our reports. In 2014, we will be reviewing progress towards achieving the Vision, working with energy industry supporters of the Vision's core principles. This customer focus will naturally continue in 2014 and will develop further as our consumer vision is implemented.



2.2. NEW LEGISLATIVE/POLICY DEVELOPMENTS

Through CEER, the energy regulators are committed to serving as valued partners for the European Institutions in their shaping of energy policy and legislative proposals. CEER will continue its analysis of and reaction to initiatives from the European Commission which impact on energy markets, as and when such proposals arise. For example, CEER is fully engaged in the European Commission's consultation on its Green Paper "A 2030 framework for climate and energy policies". We will also continue our active involvement in European Commission initiatives, including their dedicated expert groups on specific policy areas.

2.3. INTERNATIONAL WORK

CEER is active in developing relations with non-EU regulators, both through bilateral ties (e.g. the Federal Tariff Service of Russia) and with regulatory associations (such as the ECRB, MEDREG, NARUC and ICER¹). Such networking and cooperation provides the basis for identifying areas of common ground where a mutual field of interest can be explored to the benefit of both partners. Strengthening the cooperation of CEER with these institutions will continue to be a priority area.

2.4. DEVELOPING AREAS OF WORK

CEER will analyse areas where we believe there will be significant change which will impact on the regulation of the energy sector. In 2014, we intend to examine two areas which are likely to be impacted as a consequence of the introduction of smart grids and smart meters:

- a) the impact of growing demand side involvement on the grids; and
- b) the developing role of distribution system operator

There may well be other issues on the horizon which could be of major relevance to the development of Europe's energy markets. Here, we would welcome stakeholders' views.

3. OUR PROCESS FOR THE 2014 WP

CEER has established a practice of publicly consulting on its proposed deliverables. In order to present a comprehensive picture of regulatory activity in the year ahead for CEER and ACER, CEER has again decided to align the timing of its Work Programme to the statutory one required of ACER.²

In order to meet the timeline set out by the ACER Regulation, the CEER Work Programme will be developed in June through to September. To avoid consultation during the summer holiday season, we are seeking views during June. We very much hope stakeholders will be able to provide their views in this timescale.

The <u>online questionnaire</u> for this consultation is available on the CEER website and will remain open until 21 June 2013. Following its review of the comments received, CEER aims to publish its final 2014 Work Programme in September 2013.

4. QUESTIONS FOR CONSULTATION

CEER values input from stakeholders, and the opportunity to share their views on the European energy regulators Work Programme has been appreciated by stakeholders.

The purpose of the public consultation is to increase transparency and to provide us with valuable feed-back from stakeholders. The present document will be open for public consultation from 29 May until 21 June 2013.

We would in particular be interested in views on the following questions for public consultation:

- Do you agree with the scope of the work plan? Are there other things you think CEER should do as a matter of priority?
- Do you have any suggestions of issues which are likely to impact on European energy markets in the coming years and on which CEER could examine the possible future impacts as part of its 2014 Work Programme?

The ACER WP is prepared by the Director by 30 June and presented to the Commission/European Parliament and ACER Board of Regulators (BoR). The BoR, in turn, approves the draft ACER WP by 1 September. Finally, the ACER Administrative Board adopts the ACER WP before 30 September.
