WHAT IS THIS COURSE ABOUT?

National Regulatory Authorities (NRAs) have a duty to exercise monitoring activities at national and EU level to ensure competitive and well-functioning retail energy markets with empowered consumers.

While it is useful for NRA staff to understand the aims, features, and approaches in retail market monitoring from other countries, they also need to be updated on the new retail market design in Europe with the implementation of the Green Deal and RePowerEU. Therefore, participants will share their experiences and learn from each other how to deal with the challenges of market monitoring during an energy crisis.

The programme will help participants to understand the current legal framework and its objectives in order to undertake effective monitoring work. In addition, it will provide examples of good practices of retail market monitoring and monitoring of consumer protection and empowerment measures at the European and national level, covering national experiences from different countries.

This course is designed for employees from NRAs with previous experience in retail market monitoring in electricity and gas and consumer protection and empowerment.



Valuable insights

In-depth discussions during the course will cover:

- case studies on the protection of vulnerable consumers during the energy crisis;
- practical examples of protection of vulnerable consumers via the setting of supply prices and appointment of a supplier of last resort;
- approaches on how to use different indicators and metrics to self-assess the wellfunctioning retail markets which can be used beyond legal provisions.

- monitoring of consumer protection;
