# WHAT IS THIS COURSE ABOUT?

The CEER-EFET Training Program seeks to enhance the understanding of National Regulatory Authorities' staff and other energy professionals about how energy trading is conducted in the European electricity and gas markets, presented by actual practitioners and with hands-on trading simulations. It would also deepen their knowledge of how traders handle their risks and opportunities by means of transactions in relevant markets. Through a series of engaging modules, participants will gain insights into energy markets, regulatory policies, trading strategies, and risk management practices.

## Who should attend

This unique hybrid course is ideally suited for staff of National Regulatory Authorities, from junior (<2 years' experience) to senior (>10 years' experience), but representatives from other organisations are also welcomed to join.



## Valuable insights

In-depth discussions during the course will cover:

- Electricity markets: clear understanding of price formation and trading in short and forward timeframes in the wholesale electricity market;
- Gas markets: trading in the wholesale gas market, including LNG transactions and challenges;
- Trading simulations: a hands-on experience of energy trading.

- Market Insights: Explore trading strategies, market dynamics, and risk management practices;
- Regulatory Expertise: Better carry out monitoring and surveillance of wholesale energy markets at national, regional and European level;
- In-depth Knowledge: Learn key aspects of trading in the wholesale electricity and gas markets based on speakers' own operational, commercial and professional experience (rather than from an academic point of view)
